## Introduction

The authorities in charge of the control system for organic production may confer their control competences to one or more public control authorities and/or delegate their control tasks to one or more private control bodies, according to Article 27(4) of Council Regulation (EC) No 834/2007 of 28 June 2007 on organic production.

Member States shall regularly transmit to the Commission information on the names, addresses and code numbers of the designated control authorities and approved control bodies, according to Article 35 of Regulation (EC) No 834/2007.

This list is drawn up on the basis of information by the competent authorities in the Member States. It includes as well information made available by the authorities in charge of the organic control system in the non-EU members of the European Economic Area (Iceland, Liechtenstein and Norway) and in Switzerland.

Under the column "system", the control system set up is indicated as follows:

A: System of approved private control bodies

B: System of designated public control authority(ies)

C: Mixed system, with designated public control authority(ies) and approved private control bodies

For the countries in which the control authorities and/or control bodies have their activity limited to a certain specified territorial level (Länder, Regions or Autonomous Communities) the "territorial limitation" field indicates the territories to which the control activity is limited (if left empty, no territorial limitation applies).
